## **President's Remarks**

Do you ever wonder about the gap that exists between people who are pro-life and pro-choice and how can we bridge that gap? Can we find common ground in which we could have meaningful, open, and respectful discussions? Is it possible to live in a culture that appreciates the sacredness of life from conception to natural end, and freely and consistently chooses it?

A young woman teaching in the United States told me that she taught fetal development in a science class of 13-year-old students. This teacher showed pictures of the fetus at monthly stages of development and shared the awe-inspiring facts with her class. When she showed the image of a 3-month fetus the students were captivated by the little person. It was at this point that she announced ..."it is legal to abort this fetus at this 3-month stage." The students were shocked and instantly became pro-life!



Now, imagine a teacher in Canada doing something similar. In the United States, abortions are legal during the first 3 months of pregnancy. In Canada however, abortion is legal all 9 months. Therefore, teachers in Canada can display a 9-month old fetus and declare that it is legal to abort the fetus at this stage. Aside from the fact that abortion at any stage is ethically wrong, scientific, objective facts are indisputable.

Science-based reality of fetal development, from conception to birth, would open the door to meaningful, pro-life conversations. There are many resources depicting the science-based, profoundly beautiful and miraculous development of the unborn child in the womb. What about incorporating some of these resources in classrooms and in our homes with our families? Perhaps this is one way to bridge the gap? While we are at it, let's have conversations about the intrinsic value of all life: born and unborn, young and elderly, able and disabled. Perhaps the gap that exists between pro-life and pro-choice can be diminished when we take the time to pray from the heart:

#### **Prayer for Reverence for Life:**

Almighty God, giver of all that is good, We thank you for the precious gift of human life: For life in the womb, coming from your creative power, For the life of children, making us glad with their freshness and promise, For the life of young people, hoping for a better world, For the life of people who are disabled, teaching us that every life has value, For the life of the elderly, witnessing to the ageless values of patience and wisdom. Nellie Gray, the founder of the March for Life, was a pro-life warrior whose famous "life principles" are worth remembering every day. Pro-life activists around the world recall Nellie Gray's heroic and historic stand for unborn children. The key provision of her "life principles" was: "NO EXCEPTION! NO COMPROMISE!" Gray's "life principles" assert that "all human beings are created equal and are endowed by their Creator with certain unalienable rights, among which is the right to life." Accordingly, the "right to life of each human being shall be preserved and protected by every human being in the society and by the society as a whole," from conception until natural death. "The life of each human being shall be preserved and protected at each stage of the life continuum to the same extent as at each and every other stage regardless of state of health or condition of dependency," Gray emphasized.

#### Canada's Bill C-7

Introduced in February and approved in March, the Bill and Amendment expands the current Medical Assistance in Dying (MAID) law, allowing euthanasia being offered to people with chronic and debilitating diseases, as well as those suffering from mental illness, such as depression, anxiety and suicidal thoughts. Our society values suicide prevention, helping those who have lost hope and are considering ending their lives at their own hand. These individuals can now end their lives with the help of doctors providing MAID. This has been a pivotal point in law and in the protection of life at all stages. This Bill removes safeguards to protect people with disabilities from being coerced or pressured by a lack of supports into ending their lives prematurely.

Join us in showing compassion, love and support to those experiencing extreme despair. Suicide is a tragedy; a permanent solution to a temporary situation. Life is sacred! Each of us was created for an amazing purpose!
