Fall 2022

MAID Panel Report

The Expert Panel on MAID released its final report (May/22) concerning Parliament's Bill C-7 which expanded access to MAID to people who are not dying, and whose sole underlying medical condition is a mental illness. Ultimately no further protection was recommended for vulnerable Canadians, such as providing proper treatment and suicide prevention incentives. Parliament has until March 2023 to protect and support those with mental illness and stop the further expansion of MAID. We all need to be aware and encourage you to voice your concern.

In the USA – Overturning of Roe v. Wade – a HUGE step for Pro-Life

Friday, June 24th, 2022 - Precedent Setting Development!

In 1973 The Supreme Court in the USA legalized abortion nationwide. A few months ago, on June 24th, 49 years later, Pro-Life groups celebrated as the Supreme Court overturned Roe v. Wade and sent decision-making on abortion back to the individual states.

Roe permitted abortion through all nine months of pregnancy. This change in law begins a new phase for the pro-life movement. We need to defend the unborn. Please see below for some comments from American Pro-Life organizations:

HRTL Responds to Roe v Wade, with an Opinion Piece for The Hamilton Spectator

Fr. Ted Slaman, President, wrote an enlightened response to an opinion piece written in the June 29th Hamilton Spectator. The article below was sent to be published in the online edition, yet after more than a month, as far as we know, it has not been published.

OPINION PIECE - The Choice to Give Life

Some pro-choice people call pro-life people "women haters" and imply that they are irrational (see Heather Mallick's opinion piece on June 29 in the online Spec.). The truth about us is far different. We love the woman and all human beings, including those still in the womb. We are rational and caring in our thinking and acting.



We recognize the undeniable truth that the embryo or fetus in the womb is not a blob of tissue, but an intricate human being, from the moment of conception on, with her/his own unique DNA. She/he is not a potential human being, but a human being with potential (just as all who are born continue to have potential for further development). Abortion destroys that unique life. This is why we want to protect the one in the womb while caring deeply for the concerns of the mother.

Fortunately, as Mallick admits, Canada does not have the legal right to abortion enshrined in the Charter of Rights, even if Prime Minister Trudeau and other politicians pretend there is such a right. Canada's Supreme Court, in overthrowing the then-current law related to abortion in 1988, allowed parliament to legislate a new law. This never happened.

Really, how could there be such a right to abort, since abortion destroys the life of a unique, innocent human being in the early stages of development. Is there really any difference between the killing of a pre-born and the killing of a child after birth, other than her/his stage of development?

Pro-choice people are focused on the needs and wants of the woman, but with little regard for the good of the other human being involved. For pro-choice people, when a mother is happy to be pregnant, this is a wanted child, and therefore has great value. If the child is not wanted, she/he has no value, and is to be gotten rid of. Pro-lifers, on the other hand, hold that the right to life is not dependent on another person's needs or wants, but on the intrinsic nature of the human being. From the moment of conception there exists a unique human being with inalienable rights, even though ignored by the pro-choicers; that right exists whether a law recognizes it or not.

Pro-life supporters recognize that pregnancy for some is very difficult. Therefore, because we love them, we offer the mothers much-needed support through crisis pregnancy centres. There are various life-giving options she can choose instead of the death-dealing choice of abortion. We offer those options. We offer emotional, personal and financial support. We have centres where a woman can live during and after pregnancy (with her child) in a supportive home environment. We offer adoption services as well. With the right support, women are strong, and do make the right life-giving decision.

We also give support to women who have had abortions and are having a hard time dealing with that reality. I have personally dealt with women who have had an abortion, and years later were still hurting from the emotional effects of the abortion they now deeply regret. Many women who have chosen abortion have done so reluctantly, thinking that this was the only choice for them, and not realizing that this decision could affect them negatively for the rest of their lives.

Yes, the pro-life movement also has a branch that works for legislation that will recognize the intrinsic right to life of the pre-born child. We need a law against killing them. And we have a branch, such as Hamilton Right to Life, promoting education about life, and a culture that will respect all human life at all its stages.
